

CNF Excellence in Nursing Award Nomination Form Guidelines and Samples

When completing the nomination form do not include identifying information and follow these general guidelines:

1. Avoid Names or Personal Identifiers

- Do not mention the individual's name, workplace, or specific location.
- Refrain from using job titles that could single them out in a small organization or specialized team.

2. Focus on Skills and Achievements

• Highlight their professional qualities, accomplishments, and contributions without referencing unique personal details.

3. Generalize Specific Situations

• Replace identifying scenarios (e.g., specific projects or patient cases) with general examples (e.g., "led a successful initiative" instead of "implemented a new patient care protocol at XYZ Hospital").

4. Use Neutral Pronouns

• Stick to pronouns like "they," "them," or "this individual" to maintain anonymity.

8. Keep it Relevant

• Tailor the content to the purpose of the recommendation (e.g., award nomination, job application, or recognition) and align it with the criteria provided.

- Self-directed practice and advocacy for patient and family


